B.A. LL.B. Admission Procedure

Program: B.A. LL.B.

Duration: 5 Years

Total Seats: 120

Eligibility: Candidate should have passed higher secondary school/intermediate examination (10+2) or in any stream with 45% marks (42% for OBC and 40% in case of SC and ST category) from a recognized institution.

Candidates awaiting results are also eligible to appear in the test.

Fee: Rs. 25000/-* per semester

Admission Steps

1. Application Form

- ✚ Apply online only through www.prsuniv.ac.in or <http://www.prsuniv.ac.in/> from May 01, 2024.
- ✚ The application fee is Rs. 1200/- for Unreserved and OBC, and Rs. 800/- for SC, ST, EWS & Differently Abled category.
- ✚ The application fee can be paid through Credit Card, Debit Card, or Net Banking.

- ✦ Complete the online application form with accurate personal and academic details.

2. Document Submission

- ✦ Submit the following documents along with the application form:
- ✦ Copy of High School mark sheet and certificate.
- ✦ Copy of Intermediate (10+2) mark sheet and certificate.
- ✦ Transfer Certificate (TC) from the last attended institution.
- ✦ Migration Certificate (if applicable).
- ✦ Caste Certificate (for SC/ST/PH candidates).
- ✦ Passport-sized photographs (4 copies).

3. Entrance Test

- ✦ Appear for the CET-2024 entrance test as per the schedule announced on the official <https://prsuniv.ac.in/> website.
- ✦ The entrance test will assess candidates on various subjects to evaluate their aptitude for legal studies.

4. Merit List and Counseling

- ✦ A merit list will be prepared based on the entrance test scores and eligibility criteria.
- ✦ Shortlisted candidates will be called for counseling sessions.
- ✦ During counseling, candidates will be required to provide original documents for verification and select their preferred course.

5. Admission Confirmation

- ✦ Candidates who clear the counseling process will receive an admission offer.
- ✦ Pay the semester fee of Rs. 25000/-* to confirm admission.
- ✦ Note: The fee is non-refundable under any circumstances once submitted.

6. Enrollment

- ✦ Complete the enrollment process by submitting the admission fee receipt and other required documents to the administration office of INSTITUTE OF LAW AND SOCIAL SCIENCE (ILSS).
- ✦ Obtain the enrollment number and ID card.

Total Seats: 120

Eligibility:

- ✚ Graduation with 45% marks General, 45% marks for OBC and 42% for SC/ST/PH from a recognized university.
- ✚ Fee: Rs. 10000/- per semester

 - ✚ Transfer Certificate (TC) from the last attended institution.
 - ✚ Migration Certificate (if applicable).
 - ✚ Gap certificate (if applicable).
 - ✚ Caste Certificate (for SC/ST/PH candidates).
 - ✚ Passport-sized photographs (4 copies).

3. Entrance Test

- ✚ No entrance tests.

4. Admission Confirmation

- ✚ Candidates who clear the counseling process will receive an admission offer.
- ✚ Pay the semester fee of Rs. 10000/- to confirm admission.
- ✚ Note: The fee is non-refundable under any circumstances once submitted.
